Plumley Play Area
January 2016 Survey – Preliminary Report

Conclusions

The survey return percentage is low, possibly as a consequence of current and perceived future play area usage patterns. The overwhelmingly positive response however, to the proposed new play area, suggests that usage would substantially increase on completion of the upgrade.

The new play area should cater to both toddler and junior age groups and should be both imaginative and enthralling. As such the equipment and play areas provided should be multi-functional incorporating, in order of preference, as many of the items listed as possible:

Multi-play tower

Junior slide and junior swing (possibly large basket/netted swing)
Roundabout, toddler swing and a low level agility course
Play house/play 'boat 'and a toddler slide
Ground level trampoline
Climbing wall or climbing net
Tunnel

The provision of ground markings for games such as hop scotch should be incorporated in the design.

The stated preference for a rubber 'safe' surface within the play area, by 57% of respondents, should not preclude the use of other materials deemed appropriate by the designers and taking into account the wear and cleanliness characteristics of the surfaces. A multi-facetted surface would also provide a natural zoning of the area.

Benches were the preferred option for inclusion within/around the play area however picnic tables would offer more flexibility of usage provided space constraints allow.

Plumley Play Area
January 2016 Survey – Preliminary Report

Report

The survey was conducted over a period of three weeks; 200 forms were printed, 185 were delivered to houses in Plumley village and a total of 21 forms were returned, an 11% response rate. Positive and constructive answers to the questions posed were received from all bar three of the returns, 86% of respondents. It was stated, by respondents, that the increased numbers of children in Plumley required better and more varied play facilities, suitable for a wider age range.

Approximately 43% of the returns were from houses within the immediate vicinity of the play area; 38% of respondents were aged 18 to 40 and 57% aged over 40.

The existing play area equipment was considered, by 90% of respondents, to be sparse, out of date, run down and potentially unsafe; 86% of respondents stated that they would use the play area more often if it had better facilities and an improved surface.

Within the existing play area the swings were considered to be the most used by 71% of respondents and the roundabout by 19% of respondents; 48% felt that the see-saw was least used.

Seventy one percent of respondents felt that any new equipment should cater to both the 0-5 and 0-11 year age groups.

When asked which pieces of new equipment they would prefer in the play area the respondents were split as follows: 62% would like a multi-play tower; 48% a junior slide and junior swing; 38% a roundabout; 33% a large basket/netted swing, toddler swing and a low level agility course; 29% a play house, toddler slide and ground level trampoline; 19% a climbing wall and climbing net; 14% a tunnel; 10% a see-saw; 5% a sand pit and a springer car/animal.

Other items that individual respondents would like to be included are hop scotch and other simple games, a play 'boat', a rocking horse and a swing boat.

Fifty seven percent of respondents felt that a rubber 'safe' surface would be preferable, 19% wooden chippings, 14% artificial grass and 14% mixed surfaces.

Benches within the play area were preferred by 57% of respondents whilst 29% would like picnic tables and 14% would prefer both.

Update on HS2

Many people believe that HS2 has been cancelled or will not happen. HS2 however is still very much a threat to businesses, farms, property owners and residents of Cheshire.

The confusion may have been caused by the recent announcement by the Department for Transport confirming the route of HS2, but only as far as Crewe. This is now termed Phase 2a. The route from Crewe northwards, now termed Phase 2b, will not be announced until the autumn of this year (2016), some 30 months after the announcement was originally due to be made. This state of flux continues to cause worry for many people from Crewe to Lymm, property prices continue to be depressed and farmers & businesses cannot plan for the future.

The recent Phase 2a route announcement talks of assessments for a station at Crewe but does not commit. It discusses the possibility of a station either outside Crewe at Basford, originally earmarked as a maintenance depot, or surprisingly at or next to the main station in Crewe town centre. This throws up questions about the continuation of the line northwards and what it may entail for Crewe and its environs.

A petition with more than 1800 signatures, organised by Mid Cheshire Against HS2, and submitted to Cheshire West & Chester Council produced a debate by the full council who have set up a 'High Speed Rail, Task & Finish Working Group' to look at the impact and opportunities of HS2, for the borough. Mid Cheshire Against HS2 are playing an active part in the process. Visits were organised, for the working group, to farms and communities severely affected by HS2 during a tour of all road crossing points on the currently planned route. As well as the adverse effect on farms and communities, the working group are particularly interested in the impact of HS2 on the local economy and particularly the conflict between HS2 and existing and proposed economically significant projects. This includes the creation of new salt cavities for gas storage, a project which, even though it is considered to be 'of national importance', will be cancelled if HS2 is built. The working group is expected to report and make its recommendations in early spring.
